The Direct Debit Guarantee

If you request the CAF/British Horn Society to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error to your direct debit is made by **CAF/British Horn Society** or your Bank or Building Society, you are guaranteed a full and immediate refund from your branch of the amount paid from your bank account.
- If you receive a refund you are not entitled to, you must pay it back when CAF/The British Horn Society ask you to.
- You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to CAF.
